### MANAGER'S AGREEMENT FORM

Teams will not be permitted to play until a Manager's Agreement Form is signed.

As a manager or representative of my team, I agree to make my players aware of the following conditions for participation. If any player does not agree with these conditions, I will not allow them to participate and I will immediately inform the Tournament Director.

#### 1. Release (Injury to Player or to Personal Property)

In consideration of acceptance of our entry, we waive any and all claims for ourselves and our heirs and hold harmless SSUSA, Inc., any municipal including their park employees, their agents or their employees, Tournament Directors, and sponsors (hereafter tournament organizers) from and against any and all loss of liability, charges and expenses (including attorney fees) and causes of action whatever character which may arise by travel to and from, and participation in, this event. The team manager is responsible to have all team PITCHER'S NOT WEARING THE RECOMMENDED PERSONAL PROTECTION SAFETY EQUIPMENT MUST MEET WITH THE TOURNAMENT DIRECTOR TO OBTAIN THEIR LIABILITY RELEASE prior to pitching in any tournament game.

#### 2. Player Responsibility for Procuring Insurance

We are fully aware that SSUSA and the tournament organizers do not carry, or provide any medical insurance for any participants and that we are solely responsible for procuring our own individual insurance and that our team is responsible for procuring its own insurance.

#### 3. Assumption of Risk

I recognize that we assume all risks involved in arising from our participation in this tournament and we knowingly undertake the inherent risks of the sport.

#### 4. Softball Skills

I am familiar with the skills required to participate in this recreational event held by the tournament organizers (including batting, fielding, running and throwing) and have satisfied myself that my team and its players are proficient in these skills.

#### 5. Bat Use Policy Agreement

Participants between the ages of 40-49 are restricted to use only bats with the industry standard rating of 1.20 bpf or less. Any senior participant 50 years of age or older may use bats with the industry standard rating of 1.21 bpf.

All bats should clearly display the manufacture, model and the manufacturer's bpf rating on the barrel. Any bat that does not display these markings is "suspect" THAT COULD BE challenged by an opposing team manager. Manager's are asked to use common sense when challenging the use of a bat especially when bats are subject to the conditions of the game WITH normal barrel wear from use. Examinations should consist of whether the bat has been repaired in some way or altered which would render IT ineligible for use.

Penalty for using an Altered Bat: Discovery of a altered (repaired) bat in use during the play of a game will result in the player being immediately suspended from tournament play. (SEE TOURNAMENT DIRECTOR TO OBTAIN YOUR RELEASE)

#### PLAYER'S COPY OF THE PITCHER'S LIABILITY RELEASE FORM

Pitchers are encouraged to wear minimum personal protective safety equipment while pitching, an approved manufactured facemask for softball use, shin guards and a athletic cup. Pitchers who do not wear the personal protection safety equipment, all or part as described, are required to sign a release form prior to pitching in any Bemidji Lumberjack tournament game. By affixing your signature, you the pitcher, acknowledge and affirm:

#### 1. Release (Injury to Player)

By electing not to wear the above described personal protection equipment you, the Pitcher, waive all claims, individually, and by your heirs, and holds harmless SSUSA, Inc., its Board of Directors, any municipal or park facility employees, their agents or employees, tournament director, tournament organizers and sponsors from and against any and all loss liability, charges and expenses (including attorney's fees) and causes of action of whatever character which may arise for injury that may have been reasonably prevented by the wearing of the described personal protective safety equipment.

#### 2. Player Responsibility for Procuring Insurance

The Pitcher is fully aware that SSUSA does not carry, or provide, any medical insurance for any participants and that all players are solely responsible for procuring their own insurance;

#### 3. Assumption of Inherent Risk

The Pitcher recognizes that he or she assume all risks involved arising from participation in this tournament as a Pitcher electing NOT to wear the described personal protection safety equipment, and knowingly undertakes the inherent risks of the sport; and

#### 4. Softball Skills

The Pitcher is familiar with the skills required to participate as a Pitcher in an event sponsored by SSUSA (including batting, fielding, running, and throwing) and has satisfied himself or herself that they are proficient in these skills.
